

NOTICE TO BIDDERS

Notice is hereby given that sealed bids will be received by the Cinnaminson Sewerage Authority, for the Removal, Transportation and Disposal of Liquid Sewage Sludge, Contract No. 2026-3 and will be opened and read in public at the Authority Office, 1621 Riverton Road, Cinnaminson, New Jersey 08077 on **Tuesday, May 19, 2026, at 11:00 A.M.**, prevailing time.

The work includes the furnishing of all labor, material and equipment necessary or required to complete all work set forth in these Specifications for the removal, transportation and disposal of sewage sludge containing 4% to 6% solids for a one (1) year period at the rate of approximately 50,000 gallons per month.

Bidders are urged to visit the Cinnaminson Sewerage Treatment Plant for inspection of the loading area before submitting a bid. No allowances shall be made for bidder's failure to familiarize himself with the conditions at the site. Appointment must be made with the Superintendent of Operations for inspection of site.

Specifications and forms of bid for the proposed work prepared by Richard A. Alaimo Associates, Authority Engineer, have been filed in the office of said ENGINEER, at 200 High Street, Mount Holly, New Jersey, and may be inspected by prospective bidders during the regular business hours. Bidders will be furnished with a copy of the Specifications, Plans and Proposal by the ENGINEER at the cost of preparation thereof, \$20.00, nonrefundable; plus \$10.00 postage and handling if mailed. Checks shall be made payable to RICHARD A. ALAIMO ASSOCIATES.

Bids must be made on the standard Proposal form in the manner designated therein and must be enclosed in a sealed envelope bearing the name and address of the bidder and the name of the project on the outside, addressed to the Cinnaminson Sewerage Authority, and must be accompanied by Certified Check, Bid Bond or Cashier's Check drawn to the order of the Cinnaminson Sewerage Authority for ten percent (10%) of the total amount bid, provided said security need not be more than \$20,000.00.

The signed Proposal forms and bid security must be delivered to the place and on or before the hour named above. The accepted bidder must sign the contract within ten (10) days after the Notice of Award or forfeit his bid security. Bid securities will be returned to all but the three apparent lowest responsible bidders. All other bid securities will be returned within three days after awarding and signing of the contract, Saturdays, Sundays, and Holidays excepted.

This contract is subject to the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et. seq.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, Affirmative Action Regulations.
