

NOTICE TO BIDDERS

Notice is hereby given that sealed bids will be received by the Cinnaminson Sewerage Authority, for the Removal, Transportation and Disposal of Dewatered Sewage Sludge, Contract No. 2026-4 and will be opened and read in public at the Authority Office, 1621 Riverton Road, Cinnaminson, New Jersey 08077 on **Tuesday, July 7, 2026 at 11:00 A.M.**, prevailing time.

The work includes the furnishing of all labor, material and equipment necessary or required to complete all work set forth in these Specifications for the removal, transportation and disposal of dewatered sewage sludge under one of the following contracts:

- Contract 2026-4A - 130 Containers (One Year Contract)
- Contract 2026-4B - 390 Containers (Three Year Contract)
- Contract 2026-4C - 650 Containers (Five Year Contract)

Plans, Specifications and forms of bid for the proposed work prepared by Richard A. Alaimo Associates, Authority Engineer, have been filed in the office of said ENGINEER, at 200 High Street, Mount Holly, New Jersey, and may be inspected by prospective bidders during the regular business hours. Bidders will be furnished with a copy of the Specifications, Plans and Proposal by the ENGINEER at the cost of preparation thereof, **\$10.00**, nonrefundable; plus \$5.00 postage and handling if mailed. Checks shall be made payable to RICHARD A. ALAIMO ASSOCIATES.

Bids must be made on the standard Proposal form in the manner designated therein and must be enclosed in a sealed envelope bearing the name and address of the bidder and the name of the project on the outside, addressed to the Cinnaminson Sewerage Authority, and must be accompanied by Certified Check, Bid Bond or Cashier's Check drawn to the order of the Cinnaminson Sewerage Authority for ten percent (10%) of the total amount bid, provided said security need not be more than \$20,000.00.

The signed Proposal forms and bid security must be delivered to the place and on or before the hour named above. The accepted bidder must sign the contract within ten (10) days after the Notice of Award or forfeit his bid security. Bid securities will be returned to all but the three apparent lowest responsible bidders. All other bid securities will be returned within three days after awarding and signing of the contract, Saturdays, Sundays, and Holidays excepted.

This contract is subject to the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et. seq.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, Affirmative Action Regulations.
